## **An Open Letter to School Districts to Address Transgender Student Rights**


Aug. 27, 2013

As the start of another school year approaches, feelings of excitement and possibility are in the air. Parents and families are packing their little ones' backpacks and sending them off to their first days of school. Middle school and high school students are reuniting with old classmates. Teachers, administrators, and other school staff have eagerly prepared for a year of successful learning. What brings all these groups together, what makes a school community great is the common desire to provide a safe and supportive environment that encourages high quality learning for students. In consideration of your students' academic success and well-being, we ask that state and local school districts take the time to acknowledge the diversity that exists in your school community and, in particular, provide a safe and supportive space for transgender and gender non-conforming students? students whose gender identity and/or gender expression differs from the sex they were assigned at birth.

All young people have the right to safe spaces and it is a school's responsibility to ensure that the rights of all students are honored and protected. A recent [report](#) <sup>[1]</sup> from the National Center for Transgender Equality and the National Gay and Lesbian Task Force revealed, that while in grades K-12, transgender individuals reported high rates of harassment (78%), physical assault (35%), and sexual violence (12%). Numbers like these are staggering. But what is even more important for all of us to remember is that behind each of these numbers are the young people who are in school to learn not to be harassed or violated. Like all students, transgender students count on their schools to keep them safe. Bullying and harassment negatively affect ALL students.

In order to create safe, supportive environments for transgender and gender non-conforming students, school districts should require mandatory professional development for all school staff and faculty; create, revise, and implement anti-discrimination and anti-bullying policies that enumerate sexual orientation and gender identity and expression; support student-driven Gay-Straight Alliances (GSAs) or other student organizations focused on supporting lesbian, gay, bisexual, transgender, and queer (LGBTQ) youth; as well as create gender-neutral restrooms so that all students can access facilities safely and comfortably.

To ensure that transgender students get off to a good start for the 2013-14, school year we encourage you to access the following resources:
