## Legal Resources



**Students have legal rights in schools. You have the right to be protected from harassment and discrimination. And you have the right to form a Genders & Sexualities Alliance (GSA) club. Knowing and understanding your legal rights will help you create a safer environment in your school through your GSA. Use these resources to know your rights and stand up for your rights in your school.**

### **Federal Equal Access Act**

??Under the [Federal Equal Access Act](#) [1], any school that receives government funding and has at least one other non-curricular club **must also allow a GSA**. As the law states, "It shall be

unlawful for any public secondary school which receives Federal financial assistance...to deny equal access or a fair opportunity to, or discriminate against, any students who wish to conduct a meeting ...on the basis of the religious, political, philosophical, or other content of the speech at such meetings."

The law also says that your school must treat all clubs the same and let them use school resources in the same way. If your school allows other clubs to meet in classrooms, put up posters and organize school events, then they have to allow your GSA do the same.

## **FAIR Education Act - California**

The state of California requires schools to teach about the contributions of women, people of color, and other historically underrepresented groups. On January 1, 2012, the state updated these guidelines to end the exclusion of people with disabilities and lesbian, gay, bisexual and transgender people from history and social studies lessons. ## What rights does a GSA club have?

Federal and state law protects non-curricular student clubs at public schools from discrimination. This means your school can't refuse to allow the GSA to meet because the club deals with LGBT issues as long as there is at least one other non-curricular student club at your school.
